



SUPPLY OF TRANSPONDER CAPACITY ON MEASAT-3a TO ASTRO

KUALA LUMPUR, 27 May 2009 - MEASAT Satellite Systems Sdn Bhd ("MEASAT") announced today it has signed an agreement with MEASAT Broadcast Network Systems Sdn Bhd ("MBNS"), a wholly-owned subsidiary of ASTRO ALL ASIA NETWORKS, plc ("ASTRO") to supply transponder capacity on the MEASAT-3a satellite.

Under the agreement, MEASAT will provide MBNS with 6 Ku-band transponders on the MEASAT-3a satellite for a period of 15 years. The satellite, manufactured by Orbital Sciences in the USA and scheduled for launch in June 2009, will be co-located with MEASAT-3 at MEASAT's key 91.5°E orbital slot increasing capacity at that hot slot by 50%. The agreement is valued at USD189.2 Million.

"MEASAT-3a has been built to work in tandem with MEASAT-3 to support the growth plans of our existing customers," said Terry Bleakley, MEASAT's Vice President, Commercial Operations. "We are delighted to be able to support ASTRO as they expand their services."
